# **KISKATINAW PROVINCIAL PARK Purpose Statement and Zoning Plan**

## **Primary Role**

The **primary** role of Kiskatinaw Provincial Park is to provide weekend recreational opportunities, including picnicking and camping for local area residents. The park offers a place for people to enjoy swimming in the river or to try their luck with a fishing rod. The park covers 58 hectares of the Peace Lowland Ecosection and the Boreal White and Black Spruce Biogeoclimatic Zone.

## **Secondary Role**

The **secondary** role is to provide a stopover area for tourists who are driving along the Alaska Highway. An historical opportunity exists as well, since Kiskatinaw Provincial Park is located on the Old Alaska Highway next to a designated Heritage Site - a curved wooden trestle bridge which was constructed in 1942 and is one of the few found in North America.
